Please submit 4 electronic images (3 art images and 1 booth image) via email to [submission@leoarts.org](mailto:submission@leoarts.org) or on a CD with an application.

Previous year award winners do not need to pay the jury fee for the following year.

Include 2 separate checks payable to Leo Cedarville Foundation: \$20 for the jury fee (non-refundable) and \$95 for the booth fee (refundable if not accepted).

The jury committee reserves the right to refuse exhibitor of work that is not consistent with submitted images. Failure to comply will result in immediate removal with no refund.

Exhibitors must supply their own tents & displays. The Leo Cedarville Foundation and the Town of Leo-Cedarville employees and their volunteers assume no responsibility for displays or damage due to theft or other loss.

All accepted artists must be present with and exhibit their work during all hours of the fair.
